

## Exhibition Opportunities At FAVA

FAVA presents a variety of exhibitions throughout each year in both the Betsy S. Manderen Gallery (the main gallery space) and the South Gallery.

### The Members' Show:

This annual non-juried exhibition is open to all current members of FAVA. Each artist is allowed to display up to three (?) works (size permitting). If you are not a member, or your membership has lapsed, you may join when you deliver your work for the exhibition. Entry forms will be sent to FAVA members.

### The Regional Photo Show and Artist As Quiltmaker:

These juried exhibitions appear in alternate years, and guest jurors select the works for exhibition from all the pieces that are submitted. Entry forms will be available for interested artists.

### Curated Exhibitions:

The FAVA Exhibition Committee meets twice a year to review proposals submitted for possible exhibitions.

If you wish to have your work considered you will need to submit the following prior to a scheduled Exhibition Committee meeting:

1. A cover letter with your name, address, email address, and phone number.
2. A current resumé which includes exhibitions of your work.
3. 15-20 digital images of current work, or work you wish to exhibit. A list should accompany the images, providing information on medium, size, and dates.
4. An exhibition proposal describing your ideas for an exhibition at FAVA.

If you are proposing an exhibition including multiple artists you should send:

1. A cover letter with your name, address, email address, and phone number.
2. 3 digital images from each artist who will be exhibiting. A list should accompany the images, providing information on medium, size, and dates.
3. An exhibition proposal describing your ideas for a group exhibition at FAVA.

Mailed materials will be returned only if a pre-paid return mailer is included.

You will be notified of the outcome of your proposal after the scheduled meeting of the Exhibition Committee.

If your work is selected for exhibition at FAVA, Artist(s) will be asked to:

- Provide several high resolution (600 dpi) images of work from the exhibition for use on an exhibition announcement and for additional publicity.
- Provide mailing labels from the artist's mailing list if FAVA will be mailing those announcements.
- Provide an inventory list with prices (or insurance values if NFS).
- Provide an artist's statement about the exhibition.
- Provide a resumé to accompany the artist's statement.
- Deliver work to FAVA on agreed date and time, normally 7 - 10 days before opening of the exhibition. Special needs for an exhibition may require additional time.

FAVA will:

- Finalize exhibition arrangements with the artist via a signed exhibition agreement.
- Produce a postcard exhibition announcement, mail announcement to FAVA members, art organizations, and the artist's mailing list (if labels are provided).
- Publicize the exhibition.
- Install the exhibition.
- Produce labels and exhibition signage.
- Provide an inventory list with prices for visitors to the exhibition.
- Provide a public reception for the artist(s).
- Retain a 30% commission on sales from the exhibition.
- Insure the artwork while it is at FAVA.
